ORDER

In supersession to previous orders, the approval of the Commissioner, Kendriya Vidyalaya Sangathan is hereby conveyed to re-constitute the 'Internal Complaints Committee at KVS (Hqrs.), Regional Offices, ZIETs and at Vidyalaya level as per the provisions of the 'Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013' to deal with the complaints regarding sexual harassment of women at workplace, in terms of the provisions of Section 4(2) of the said Act enforced on 9th December, 2013.

Accordingly, in order to ensure effective implementation of the 'Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013' and to bring uniformity in the composition of ICC at every unit of KVS, the necessary instructions for composition of the 'Internal Complaint Committee' (ICC) and its jurisdictions as approved by the competent authority is conveyed as under:

Note:

(1) The composition of ICC at all levels will be subject to the condition that one-half of the total members so nominated shall be women.

- (2) All the members of the ICC including the Presiding Officer shall hold office not exceeding three years from the date of nomination.
- (3) A copy of the Act, as well as a compendium on Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 is being forwarded to the DCs of all ROs & Directors of all ZIETS for further dissemination to all offices/ units under their administrative control.
- (4) The inquiry into the complaints of sexual harassment at workplace is to be conducted strictly as per the procedure and timelines prescribed in the Act and the guidelines issued from time to time by the Govt. of India.
