MEMORANDUM

3. His pay in the above Pay level of Pay Matrix, as Deputy Commissioner, will be fixed as per provisions of FR 22(I)(a)(1) and as per instructions set forth in the Govt. of India, Ministry of Finance OM No.F.1/1/2008-IC dated 13.09.2008 as applicable to the employees of KVS. He will have an option to get his pay fixed from (i) the date of joining on promotion OR (ii) the date of accrual of next increment in the grade held by him. The option shall be exercised by him within one month from the date of joining on promotion and option once exercised will be final.

4. If he does not submit the acceptance by the stipulated date, it would be presumed that he has declined the offer of promotion. Refusal of promotion should entail no fresh offer of promotion being made to him for a period of ONE YEAR from the date of refusal. He, on eventual promotion to the above post, will lose seniority vis-a-vis erstwhile junior promoted to the above post earlier, irrespective of the fact whether the post in question is filled by selection or seniority. In case the reasons adduced by him for refusal are not acceptable to the Appointing Authority, the promotion may be enforced.
