Issue of serving CGHS cards to compassionate appointees holding CGHS pensioner card

This Ministry has been receiving requests from compassionate appointees holding CGHS pensioner card for issuance of serving CGHS cards to them.

- 2. The matter has been examined in this Ministry in view of the fact that family pensioner holding a pensioner CGHS card and appointed on compassionate grounds may retire in due course with a higher entitlement compared to the present entitlement and as such the beneficiary would be in a position of disadvantage if he/she continues availing CGHS facility on the existing pensioner card issued to him/her.
- 3. Accordingly, it has been decided to issue serving CGHS cards to those compassionate appointees who wish to apply for serving CGHS cards instead of availing CGHS facilities on pensioner CGHS card.
- 4. It is further informed that those compassionate appointees who had already applied for / holding family pensioner CGHS card will be refunded the subscription an ount after deducting the amount for the period for which CGHS facilities have already been availed as family pensioner as per table given below:

For eg.: A compassionate appointee who was issued a family pensioner CGHS card on 15-2-2015 and subsequently surrendered it on 15-1-2016 after issue of serving CGHS card will be refunded as under:—

5. The contribution and entitlement of the compassionate appointee while issuing pensioner card to them in future, shall be decided on the basis of the pay drawn by them at the time of retirement.

G.I., CGHS., Office Order No. 3-2/2011-12/CGHS/KNP/4383-98, dated 7-10-2016

Revoking of suspension of empanelment of M/s. Family Hospital and Research Centre, A-9 Awas Vikas Hanspuram, Kanpur

With reference to the above-mentioned subject, the undersigned is directed to draw attention to the Office Order No. 3-2/2011-12/CGHS/KNP/2861-77, dated 6-7-2016 vide which empanelment of M/s. Family Hospital and Research Centre, A-9 Awas Vikas Hanspuram, Kanpur was suspended from the list of empanelled Hospital under CGHS, Kanpur for three months. It has now been decided to revoke suspension of M/s. Family Hospital and Research Centre, A-9 Awas Vikas Hanspuram, Kanpur, in public interest with issuance of this order. The empanelment would be for all those facilities available in the Hospital and as per same terms and conditions on which it was empanelled prior to 6-7-2016.

Amendment to CCS (Pension) Rules, 1972

- G.S.R. 962(E).— In exercise of the powers conferred by the proviso to Article 309, and Clause (5) of Article 148 of the Constitution and after consultation with the Comptroller and Auditor-General of India in relation to persons serving in the Indian Audit and Accounts Department, the President hereby makes the following rules further to amend the Central Civil Services (Pension) Rules, 1972, namely:—
 - 1. (1) These rules may be called the Central Civil Services (Pension) Amendment Rules, 2016.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
 - 2. In the Central Civil Services (Rension) Rules, 1972, for Rule 38, the following rule shall be substituted, namely:—

"38 Invalid Pension

(1) The case of a Government servant acquiring a disability, where the provisions of Section 47 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 (1 of 1996) are applicable shall be governed by the provisions of the said section:

Provided that such employee shall produce a disability certificate from the Competent Authority as prescribed under the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Rules, 1996, as amended from time-to-time.

- (2) If a Government servant, in a case where the provisions of Section 47 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 (1 of 1996) are not applicable, retires from the service on account of any bodily or mental infirmity which permanently incapacitates him for the service, he may be granted invalid pension or service gratuity in accordance with Rule 49, depending upon the length of his qualifying service on the date of retirement.
- (3) Where a Government servant, referred to in sub-rule (2), applies for an invalid pension, he shall be required to submit a medical certificate of incapacity from the following Medical Authority, namely:—
 - (a) a Medical Board in the case of a Gazetted Government servant and of a non-Gazetted Government servant whose pay, as

defined in Rule 9 (21) of the Fundamental Rules, exceeds fifty-four thousand rupees per mensem;

- Civil Surgeon or a District Medical Officer or Medical Officer of equivalent status in other cases.
- Note 1.— No medical certificate of incapacity for service may be granted unless the applicant produces a letter to show that the Head of his Office or Department is aware of the intention of the applicant to appear before the Medical Authority and the Medical Authority shall also be supplied by the Head of the Office or Department in which the applicant is employed with a statement of what appears from official records to be the age of the applicant, and if a service book is being maintained for the applicant, the age recorded therein should be reported.
- Note 2.—A lady doctor shall be included as a member of the Medical Board when a woman candidate is to be examined.
- (4) The form of the Medical Certificate to be granted by the Medical Authority specified in sub-rule (3) shall be as in Form 23.
- (5) Where the Medical Anthority referred to in sub-rule (3) has extrared a Government servant mentioned in sub-rule (2) fit for further vice of less laborious character than that which he had been doing, he will, provided he is willing to be so employed, be employed on lower stand if there he no means of employing him even on a lower post, he may be admitted to invalid pension or service gratuity, as the case may be, under Rule 49."
