**Recovery of Special Licence Fee under FR-45-B in respect of  
General Pool Accommodation including Hostel Accommodation,  
Servant Quarters, Garages in Delhi**

This is in supersession of this Directorate's order of even number, dated 11-3-2015, wherein the revised Special Licence Fees under FR-45-B for various types of General Pool Government Accommodations with effect from 1-7-2013 were notified. It has been decided to simplify the procedure of revising the Special Licence Fee under FR-45-B to be charged from allottees i.e., Government servants and other ineligible offices / organization for short period / temporary allotment of General Pool Residential accommodation on special purposes. The Special Licence Fee is practically applied where flat rate of licence fee under FR-45-A is not applicable. Accordingly, it has been decided to charge the Special Licence Fee uniformly in multiples of flat rate of licence fee, as prescribed for damages. The revised Special Licence Fees for various types of General Pool Government Accommodations are as follows:—

**Income Tax (Sixth Amendment) Rules, 2015**

**S.O. 1002 (E).**— In exercise of the powers conferred by Section 295, read with Clause (14) of Section 10 of the Income Tax Act, 1961 (43 of 1961), the Central Board of Direct Taxes hereby makes the following rules further to amend the Income Tax Rules, 1962, namely:—

- (1) These rules may be called the Income Tax (Sixth Amendment) Rules, 2015.
  - (2) They shall come into force on the 1st day of April, 2015.
2. In the Income Tax Rules, 1962, in Rule 2-BB, in sub-rule (2), in the Table,—
- (a) against Serial Number 10, in the entry under Column (4), relating to the extent to which allowance is exempt, for the letters, figures and words “₹ 800 per month”, the letters, figures and words “₹ 1,600 per month” shall be *substituted*;
  - (b) against Serial Number 11, in the entry under Column (4), relating to the extent to which allowance is exempt, for the letters, figures and words “₹ 1,600 per month”, the letters, figures and words “₹ 3,200 per month” shall be *substituted*.

**CS (MA) Rules 1944 — Renewal of name of the AMA for the  
treatment of Central Government Employees and Members  
of their family for the period from 1-8-2015 to 31-7-2016**

In terms of Ministry of Health and Family Planning's (Department of Health) instructions contained in O.M. No. 9-14025/133/79-MS, dated 28-5-1982 and C & A.G. Circular No. 445-Audit/17/87/III-90(86), dated 10-8-1990 and as per Rule 2-A (iv) of the CS (MA) Rules, 1944, the name of the Private Medical Practitioners, as mentioned in Annexure-AMA-1, are hereby renewed as Authorized Medical Attendant during the normal working hours for the treatment of the Central Government Employees' and members of their family stationed at, or passing through, Kolkata and its adjoining Municipalities (as shown against each AMA) which are not covered by CGHS for a period of one year, i.e., from 1-8-2015 to 31-7-2016.

Annexure-I contains the names of the Authorized Medical Attendants who were empanelled during the year 2014-15, but have not submitted application for renewal as AMA for the year 2015-16, and have expressed their unwillingness to continue. Accordingly, their names are hereby removed from the list of Authorized Medical Attendants for the year 2015-16.

**(IMPORTANT NOTE FOR THE AMAs  
TO BE OBSERVED STRICTLY)**

1. AMAs are requested to submit applications for renewal at least 3 months before the date of expiry of the present term. The CGEWCC reserves the right to delete any name due to non-receipt of application for renewal in time.
2. AMAs are requested not to prescribe medicines for more than 3 to 4 days at a time. However, in case of 3 or 4 consultations, the treatment should be restricted to maximum period of ten days. The fees for consultation and injection should be taken as per GI., M.H., O.M. No. S-14025/10/2010-MS, dated 17-3-2011 (Sl. No. 65 of Swamy's Annual, 2011) of Ministry of Health and Family Welfare (Department of Health), New Delhi.
3. Any change in address / degree, etc., should be intimated immediately with documentary evidence. In case of death of AMA, intimation has to be sent to the Secretary, CGEWCC, Kolkata by the nearest relative of the AMA with a copy of death certificate.

**Revision of pension of pre-2006 pensioners**

The undersigned is directed to say that as per Para 4.2 of this Department's OM of even number, dated 1.9.2008 relating to revision of pension of pre-2006 pensioners with effect from 1.1.2006, the revised pension with effect from 1.1.2006, in no case, shall be lower than 50% of the sum of the minimum of pay in the pay band and the grade pay thereon corresponding to the pre-revised pay scale from which the pensioner had retired. A clarification was issued vide DoP&PW, OM of even number, dated 3.10.2008 that the pension calculated at 50% of the minimum of the pay in the pay band (irrespective of the pre-revised scale of pay) plus the grade pay corresponding to the pre-revised pay scale.

2. Several petitions were filed in Central Administrative Tribunal, Principal Bench, New Delhi *inter alia* claiming that the revised pension of the pre-2006 pensioners should not be less than 50% of the minimum of the pay band plus grade pay, corresponding to the pre-revised pay scale from which pensioner had retired, as arrived at with reference to the fitment tables annexed to Ministry of Finance, Department of Expenditure O.M.No.1/1/2008-IC, dated the 30<sup>th</sup> August, 2008. Hon'ble CAT, Principal Bench, New Delhi *vide* its common order, dated 1.11.2011 in O.A No.655 of 2010 and three other connected OAs directed to re-fix the pension of all pre-2006 retirees with effect from 1.1.2006 based on the Resolution, dated 29.8.2008 of the Department of Pension and Pensioners Welfare and in the light of the observations of Hon'ble CAT in that order.



3. The above order was challenged by the Government by filing Writ Petition No.1535 of 2012 in respect of O.A.No.655 of 2010 and W.P.No.2348-50/12 in respect of the three other connected OAs in the High Court of Delhi. The Hon'ble High Court in its common Order, dated 29.4.2013 noted that the DoP&PW had in the meanwhile, issued an O.M.No.38/37/08-P&PW(A), dated 28-1-2013 which provided for stepping up of pension of pre-2006 pensioners with effect from 24-9-2012 to 50% of the minimum of pay in the pay band and grade pay corresponding to pre-revised pay scale from which the pensioner had retired. Hon'ble High Court observed that the only issue which survived was, with reference to Paragraph 9 of OM, dated 28-1-2013 which makes it applicable with effect from 24-9-2012 instead of 1-1-2006. Hon'ble High Court of Delhi dismissed the Writ Petition No.1535 of 2012 along with three other Writ Petitions vide its order, dated 29-4-2013. Special Leave Petitions (No.23055 of 2013 and No.36148-50 of 2013) filed against the said order, dated 29-4-2013 of the Hon'ble Delhi High Court have also been dismissed by the Hon'ble Supreme Court.

4. Accordingly, in compliance with the above judicial pronouncements, it has been decided that the pension / family pension of all pre-2006 pensioners / family pensioners may be revised in accordance with this Department's O.M. No. 38/37/08-P&PW(A), dated 28-1-2013 with effect from 1-1-2006 instead of 24-9-2012. Further, this benefit has already been granted to the Applicants in O.A. No. 655 of 2010 vide OM of even number, dated 26-8-2014 read with OM, dated 19-9-2014 following dismissal of SLP (C) No. 23055 of 2013 by the Hon'ble Supreme Court.

5. In case the consolidated pension / family pension calculated as per Para. 4.1 of O.M. No. 38/37/08-P&PW(A), dated 1-9-2008 is higher than the pension / family pension calculated in the manner indicated in the OM, dated 28-1-2013, the same (higher consolidated pension / family pension) will continue to be treated as basic pension / family pension.

6. All other conditions as given in O.M. No. 38/37/08-P&PW(A), dated 1-9-2008, as amended from time to time shall remain unchanged.

7. Ministry of Agriculture, etc. are requested to bring the contents of these orders to the notice of Controller of Accounts / Pay and Accounts Officers and Attached and Subordinate Offices under them on a top priority basis. All pension disbursing offices are also advised to prominently display these orders on their notice-boards for the benefit of pensioners.

8. This issues with the approval of Ministry of Finance ID Note No. 1(9)/E.V/2011-Vol.II, dated 24-7-2015.

**Issue of Pensioners' Identity Card to pensioners**

The undersigned is directed to say that the instructions were issued by this Department vide O.M.No.41/12/2000-P&PW (Dated), dated 16-11-2000 for issue of Identity Cards to Central Government pensioners. These instructions were reiterated/clarified vide this Department's OMs of even number, dated 30-4-2013 and 25-7-2013. It has been observed that various Departments/Offices are either not issuing pensioners Identity Card to the retired employees or the Identity Cards are not in the format prescribed vide this Department's OM, dated 25-7-2013

2. The matter has been reviewed in this Department. It has been decided that apart from the details already prescribed, the Pensioners Identity Card should include the Aadhaar Number of the pensioner (if available). Accordingly, a revised format for the pensioners Identity Card is enclosed (Annexure-I and Annexure-II).

3. Further, the following specifications are laid down for the pensioners Identity Card to be issued by the Departments / Offices from which the pensioner retired:—

- (i) The Pensioners Identity Card should be in the prescribed format.
- (ii) The Identity Card should be of the standard size of 8 ½ cm x 5 ¼ cm.
- (iii) The Pensioners Identity Card should be printed (and not hand-written) on good quality paper of 125 GSM or equivalent.
- (iv) The Identity Card would be got laminated by the Department / Office before handing it over to the pensioner.

4. All Departments in the Government of India are requested to issue suitable instructions to the Offices under their control to invariably issue Identity Card to the pensioners in accordance with the instructions issued by this Department.

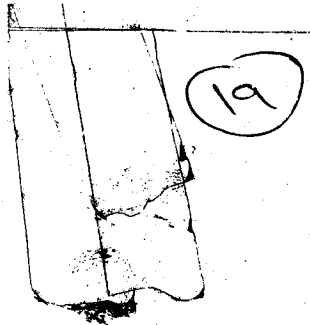

Reference is invited to Ministry of Finance, Department of Expenditure O.M.No.21(2)/2008-E.II(B), dated the 29<sup>th</sup> August, 2008 regarding grant of Transport Allowance to Central Government employees, consequent upon implementation of the recommendations of the Sixth Central Pay Commission(6<sup>th</sup> CPC).

2. The Government has since considered the re-classification of cities / towns / localities as per Census-2011 (population criteria) for the purpose of Transport Allowance. Accordingly, the President is pleased to decide the revised classification of cities, towns and localities, for the purpose of grant of Transport Allowance at higher rates to Central Government employees, as per Annexure-I. Therefore, the table below Para. 1 of OM, dated 29-8-2008 stands partially *modified* as under:—
