Sir/Madam,

Please refer to this office letter No.F.1-1/2015/KVS (JC-Fin.) dated 10.12.2015 and 18.12.2015 wherein it was directed that payment of remuneration to all contractual teachers may be made by 5<sup>th</sup> of the following month.

2) In this regard it is further stated that during the year 2014 it has been decided by the Competent Authority that salary to the contractual staff will be made out of VVN fund. It was also decided that in case of non availability of sufficient funds under VVN account in the concerned Vidyalaya, then funds may be made available out of Regional Office Vidyalaya Vikas Nidhi Deposit Account as may be seen from the letter earlier circulated by this office vide No.F.110238/70/2011-KVS(Budget) dated 8.12.2014. It is, however, observed that inspite of the issue of clearcut instructions by KVS (HQ) **Regional Offices Guwahati & Mumbai** have furnished the requisition of funds to KVS (HQ) for the purpose of payment of remuneration to Contractual Teachers under **School Fund Account/Govt. Grants**.

3) It is, therefore, suggested once again that while furnishing the requirement of funds from Govt. Grants the particular head of Account "Contractual Teacher" may not be added in the column rather it may be treated as "deleted" from the old format. However if there is a genuine need/demand for funds from **VVN KVS HQ** then the same may be furnished separately to this office for the purpose of payment

of remuneration to contractual teachers in the prescribed format as given below:

The instruction issued by KVS in the year 2014 about the payment of remuneration to contractual teachers out of Kendriya Vidyalaya VVN Account/Regional Office VVN Deposit Account still holds good.
