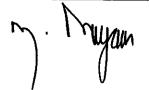

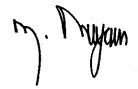

3 Submission of Annual Accounts of the Sangathan for the Year 2014-15 for Certification by CAG

As per the time schedule prescribed by the Committee on papers laid down on the table of both the houses of parliament, the Sangathan has to furnish the consolidated Annual Accounts latest by 30th June 2015 to the Office of the Director General of Audit, Central Revenues for Audit and Certification. In terms of the letter No. AMG-IV/SAR/Miscl/9-5/2015-16 dated 28.5.2015 issued by the Director General of Audit, (Central Expenditure) New Delhi, the accounts must be approved by the GB/Executive Committee /Commission/Competent Authority , as may be prescribed in the bylaws/Memorandum of Association/act/rules & regulations before submission to CAG for its certification.

The Annual Accounts of the Sangathan for the year 2014-15 have been compiled and consolidated with all relevant schedules required thereon in the new format showing the details of Fund Based Accounting as per the direction of MHRD.

The Finance Committee, KVS may kindly consider the Annual Accounts and recommend the same to the Board of Governors of KVS for its approval for further submission of the Accounts to Director General of Audit (Central Expenditure) for its Audit and Certification.

The Committee after detailed deliberation on the Annual Accounts of the Sangathan for the financial year 2014-15 recommended to Board of Governors, KVS for its approval for handing over the Accounts to the C & AG for its audit.

The Finance Committee further directed that KVS may seek additional funds towards reimbursement of RTE expenditure from MHRD under Sarva Shiksha Abhiyaan (SSA) Scheme.

4 Outsourcing of Internal Audit of Vidyalayas to CAG empanelled CA Firms.

The Agenda for strengthening of Internal Audit Function in Kendriya Vidyalaya Sangathan was placed in the Finance Committee Meeting held on 28.11.2014. The Committee considered the Agenda on the subject of Strengthening of Internal Audit in KVS but directed that the new scheme of out sourcing of Internal Audit work as introduced in 3 Kendriya Vidyalayas of Delhi/ Gurgaon Region may further be extended to all other Regions. Accordingly each RO should take steps to outsource the Internal Audit work of Kendriya Vidyalaya's through Chartered Accountant Firms at their level. The Committee desired that KVS HQ should make efforts to get the details from various Regions about Name of CA firms empanelled in the State AG, Number of Firms responded to undertake the Internal Audit Work, Comparative statement, L1 firm and its rate, total expenditure payable towards Audit Fees and TA/DA etc. per annum so as to work out the financial implication.

In compliance to the above directions, Deputy Commissioner of the Regional Offices were directed vide this office letter 189/2014/KVS(HQ)/JC (Fin.) dated 06.02.2015 to collect the details of Chartered Accountants Firms which are empanelled in the Office of the Comptroller & Auditor General of India. The list of the CA Firms which are empanelled in the Office of the Comptroller & Auditor General of India was also obtained by KVS (HQ) and circulated to all Regional Offices vide letter No. F.No.1-189/2014/KVS(HQ)/JC(Fin) dated 24.04.2015 for facilitating the RO with the direction to obtain the rates from such empanelled firms situated in their localities for comparison and compilation. The requisite information including Comparative statement, L1 firm and its rate, total expenditure payable towards Audit Fees and TA/DA etc. per annum have been received from all the Regional Offices

The Committee made the following observations upon perusal of the rates provided by various Regional Offices towards Audit Fees, TA/DA and Service Tax for outsourcing of Internal Audit work to CA firms.

Abnormal variation of rates noted between the highest and the lowest one. e.g. (i) Delhi & Ranchi (ii) Agra, Gurgaon and Delhi (iii) Kolkata and Mumbai etc.

Number of Kendriya Vidyalayas and amount payable for each Kendriya Vidyalayas were not cited in the statement to make an overall view about the rates proposed by the firms.

The Chartered Accountant firms perhaps quoted the rates without studying the scope of audit Work

and as per the said statement total financial implication involved on this matter has been worked out and attached.

The proposed expenditure to the tune of Rs.24,027,748/- for one year audit will be met out of Non-Plan grants received from the Govt. of India. In future the expenditure for one year audit of all KVs may increase depending upon opening of new KVs. Also, CAG will be kept informed of the progress of internal audit in all KVs and also the performance of the approved CA firms.

Finance Committee may recommend to the Board of Governors for the outsourcing of Internal Audit of all Vidyalayas to the CAG empanelled CA firms.

The Committee, therefore, suggested that the KVS may examine the proposal afresh and bring these details to the Finance Committee in its next meeting.

In the end, the Chairperson directed that KVS should take up the matter with defaulting Project Sector Kendriya Vidyalayas in right earnest & letters should be written to concerned Secretary/ Hon'ble Union Minister from KVS/MHRD side.

The Meeting ended with a vote of thanks to the chair.
