विषय: Regarding Workshop Based Activities (WBA) programme & Term End Examinations(TEE) of CPPDPT.

महोदय/महोदया,

As per decision taken on July 01, 2015 in the Dy. Commissioner's Conference, the Certificate Programme for Professional Development of Primary Teachers(CPPDPT) will continue to be implemented in KVS in keeping with the NCTE guidelines 2010, in wake of RTE Act 2009.

The Third phase of the CPPDPT has not initiated as yet due to various factors including the process of Performance Evaluation Review of the first two phases. The enrolment for the Third Phase (Jan. to June, 2015) of CPPDPT is expected to be done in December, 2015.

The maximum duration for completing the CPPDPT programme is 18 months and the registration of those enrolled in July 2014 will end in December 2015. It has been brought to notice that some PRTs enrolled in Phase-1 and Phase-2 of CPPDPT have either not attended the mandatory 15-day Workshop Based Activities (WBA) programme or have not cleared the Term End Examination(TEE) conducted by IGNOU. Therefore, it has been decided that the 15-day WBA programme be organized as per requirement in the Programme Study Centres (PSCs) during Octo40ber-November 2015.

Dy. Commissioners of all KVS Regional Offices are accordingly requested:


- To finalize the exact dates (as per their convenience, but only during October-November 2015) for the 15-day WBA programme in their region.
- To decide which PSCs under their jurisdiction will be the venues of the WBA programme, depending on the number and location of PRTs (enrolled in Phase-1 and Phase-2 but not completed the mandatory 15-days' WBA programme till now) to be deputed for it.
- To direct the Programme Incharges (PICs) of the PSCs, to guide the PRTs concerned to fill their forms for the TEE of December 2015 within the time stipulated by the IGNOU Regional Centres.

The Dy. Commissioners of all KVS Regional Offices are also requested to compile information from their region and send (in excel-sheet) only in the following format by e-mail only at actrgkvsHQ@gmail.com latest by October 05, 2015.
