PUBLIC NOTICE

Cancellation of Interviews held in March, 2012 for filling up the posts of TGT (English/Hindi/Sanskrit/ Maths/Science/ Social Studies) and Primary Teacher to be filled up by direct recruitment for the year 2011-12.

Kendriya Vidyalaya Sangathan had issued an advertisement in the Employment News (Weekly) dated 30 October-05 November, 2010 for filling up the posts of TGT (English/Hindi/Sanskrit/Maths/Science/Social Studies) and Primary Teacher to be filled up by direct recruitment for the year 2011-12.

Kendriya Vidyalaya Sangathan conducted preliminary examination on 12.02.2011 at All India level but the main examination could not be conducted due to adoption by KVS of Central Teacher Eligibility Test introduced by the Government of India.

Kendriya Vidyalaya Sangathan shortlisted the candidates in order of their merit in Preliminary Examination held on 12.02.2011 and requested them to appear in the Central Teacher Eligibility Test (CTET) conducted by the Central Board of Secondary Education (CBSE), New Delhi on 26th June, 2011 as per the guidelines issued by the National Council for Teacher Education (NCTE). The candidates were also advised to send the marks sheet of their CTET to KVS (HQ), New Delhi within fifteen days of declaration of the result of CTET for further necessary action. After receipt of the marks sheet of CTET from the candidates, Kendriya Vidyalaya Sangathan compiled the result of CTET for interview purpose and also fixed cut off marks.

Since the candidates had already gone through the preliminary examination and as per the Govt. of India Notification candidates also appeared in CTET conducted by the CBSE, KVS decided that based on the merit of CTET, the candidates would be called for interview as per the cut off marks of CTET fixed by the KVS and accordingly the interviews were conducted from 12-26 March, 2012 keeping in view the larger interest of the students as the Vidyalayas were running without teachers and the recruitment process was badly delayed.

Aggrieved by the decision of the KVS some of the candidates filed OAs in Hon'ble CATs at various cities. The Hon'ble CATs declared the interviews conducted in March, 2012 as illegal and directed the KVS to re-start the process of selection, by conducting the already notified Main Examination allowing all those candidates who had passed Preliminary Examination conducted by KVS on 12.02.2011 and have also qualified the statutorily prescribed CTET held on 26.06.2011.

The judgment of Hon'ble CAT, Principal Bench, New Delhi and Hon'ble CAT, Ernakulam was challenged by KVS in the Hon'ble High Court of Delhi and in Hon'ble High Court of Kerala at Ernakulam. The Hon'ble High Court of Kerala at Ernakulam upheld the judgment/orders of Hon'ble CAT, Ernakulam.

Now Kendriya Vidyalaya Sangathan has decided to comply with the judgment of Hon'ble CATs and accordingly hereby declares the interview conducted during 12-26 March, 2012 for the posts of TGT (English/Hindi/Sanskrit/Maths/Science/ Social Studies) and Primary Teacher to be filled up by direct recruitment for the year 2011-12 as cancelled. Now the recruitment process advertised in the Employment News (Weekly) dated 30 October - 05 November, 2010 will be followed by the KVS. Out of the candidates shortlisted for appearing in the CTET conducted by CBSE on 26.06.2011 on the basis of their performance in Preliminary Examination held on 12.02.2011, those candidates who have qualified the CTET securing 90 marks for General candidates and 82 marks for OBC/SC/ST/Persons with Disability candidates will be called for Main Examination. The schedule of main examination will be announced shortly.
