Further, pursuant to Clause-I(ii) of Annexure-I of the norms prescribed for opening of new Kendriya Vidyalayas under Civil Sector, the sponsoring authority is required to transfer the identified and demarcated land to KVS on lease or permanent transfer prior to opening of new Kendriya Vidyalayas.

Necessary administrative Sanction Orders for starting the new KV will be issued immediately after transfer of land in favour of KVS and thereafter Kendriya Vidyalaya will be made functional in the temporary accommodation provided by the sponsoring authority.

In case, the required extent of land is not transferred in favour of KVS within one year of the issue of this communication, this approval will be withdrawn & will be utilized for another suitable location. Therefore, all sponsoring authorities are required to transfer the land in favour of said Kendriya Vidyalaya to enable Kendriya Vidyalaya Sangathan to issue administrative sanction orders for opening the new KV and to make the Vidyalaya functional from Class I to V (single section) with consequential growth based on feasibility
