





Opening of CGHS Wellness Centre(Allopathic)at
Dhanbad

This is for information of all eligible Central Government employees/Central Government Pensioners, ex-MPs and other eligible stakeholders that a Central Government Health Scheme (CGHS) Wellness Centre has started functioning at Bertand, Dhanbad - 826001 from 1st April,2019 to provide comprehensive medical facilities.

The CGHS Wellness Centre at Dhanbad shall cover all eligible Central Government employees residing within 5 km radius of the Wellness Centre and eligible pensioner and ex-MPs etc, living in and around Dhanbad as per CGHS guidelines.

The CGHS beneficiaries shall be able to avail the CGHS facilities through the Wellness Centre from 7.30 a.m. to 2.00p.m. on all days, except Sundays and Gazetted holidays.

The CGHS Wellness Centre shall be under the administrative control of Additional Director,CGHS, Ranchi(Tel No.,0651-2480147)

**Clarification regarding Oxygen Charges for treatment at
private hospitals under CGHS**

With reference to the above-mentioned subject, the undersigned is directed to clarify that the CGHS rate for 'Oxygen' for treatment in the

Private Hospitals were revised with effect from 1-10-2014 and the rate is ₹ 58 per hour in NABH (National Accreditation Board for Hospitals and Healthcare Providers), Accredited Hospitals and ₹ 50 per hour in non-NABH Accredited hospitals and is at Code No. 512 in the CGHS Rate list, which is available on CGHS Website at cghs.gov.in

Opening of CGHS Wellness Centre at Sonipat

The formalities of operationalization of new CGHS Wellness Centre (D-103) at H.No.58, Sector-15, Part-IV Sonipat, Haryana were initiated on 7-3-2019 and the same will start functioning shortly from the above premises. The area within the radius of 5 Km of Wellness Centre is covered under the CGHS WC Sonipat for serving eligible Central Government Employees. However, in the terms of OM No.C.14012/02/2018/CGHS-III/DIR, dated 6-4-2018 one time option is available to the serving Central Government Employees residing outside of covered area but within the municipal limit of the city to enroll themselves with the above Wellness Centre.

Central Government pensioners irrespective of their place of residence are eligible to enroll themselves with the above CGHS WC Sonipat.
