With regard to the subject cited above, this is to inform that the approval of the competent authority of KVS has been conveyed to issue offer of appointments to 83 candidates selected for appointment on the basis of compassionate ground during the year 2018 & 2019 (List enclosed).

KVS has been receiving lot of representations from individuals and their relatives and public representatives. List of all candidates who have been selected for appointments and who could not be selected is being sent to all Regional Offices with the request to intimate the position to all candidates of your region. This list contains merit points obtained by the respective candidates which is a sole criterion for appointments on compassionate grounds. This way unnecessary correspondence may be reduced.
