Sir/ Madam,

Reference is made to the Provisionally selected candidates for promotion to the post of PGT & TGT through LDCE-2018 for the vacancy years from 2014-15 to 2018 on KVS Website on 31-01-2019 and it is informed that representations/ submissions/ requests for corrections of discrepancies in the eligibility etc. are being received from various sources due to which no further action is possible at this end presently until the issues involved are resolved completely and position becomes crystal clear.

Therefore, relevant details of all the candidates declared passed by the Examination Agency in LDCE-2018 for the post of T.G.T. for the respective Vacancy Years from 2014-15 to 2018 are being enclosed in EXCEL format. Further the actual eligibility of each listed candidate w.r.t. specific Vacancy Year is to be checked through the enclosed CHECK LIST devised for the purpose, Terms & Conditions, LDCE-2018 Notification dated 09-04-2018 and thereafter TGT Subject wise compilation of the revalidated information prepared by ensuring strict compliance of under mentioned points be furnished to KVS (HQ) in EXCEL format & Attested Scanned version of the same also.

- 1) The Principals/ Directors/ Controlling Officers/ Deputy Commissioners concerned shall check authenticity of the candidates so selected by verifying all details including Roll Numbers, and validate Eligibility for promotion/ specific Vacancy Year on the crucial date of eligibility, Disciplinary/ Vigilance/ Criminal proceedings, Currency of Penalty, pendency of Court Case pertaining to eligibility of the each applicant.
- 2) Eligibility of the LDCE-2018 candidate for the specific Vacancy Year (i.e. from 2014-15 to 2018) must be synchronized with the LDCE-2018 Notification dated 09-04-2018 and Recruitment Rules as applicable. Moreover, Eligibility of a candidate shall be considered complete in every respect, if and only if, on the Crucial Date of Eligibility, all the essential qualifications/ requirements have been attained in advance or as on crucial date i.e. (1) Educational Qualification; (2) Professional Qualification; & (3) Essential Working Experience taking all together.

- 3) Any discrepancy/ difference in r/o Year of selection, Category (UR, SC & ST), Date of Birth or in the Actual Eligibility of the empanelled candidate as derived from the aforesaid manner mentioned in Point-2) etc., the concerned Principals/ Officers are directed not to relieve/ allow to join candidates unless any further revision/ correction/ decision is received from the Competent Authority of KVS (HQ).
- 4) The Principals/ Directors/ Dy.Commissioners/ Controlling Officers are expected to be extra vigilant regarding the ineligible candidates permitted to appear in LDCE-2018 in compliance to Court Order or any other compulsion (if any) and are to be identified in advance because such promotions through LDCE-2018 are to be kept in abeyance till final decision of the Hon'ble Court. Accordingly Establishment Branch of KVS(HQ) is also to be informed by the Dy. Commissioner concerned to keep equal number of vacancies spare till final outcome of the case under intimation to the undersigned.
- 5) Concerned Dy.Commissioners/ Controlling Officers are further directed to prepare a single compilation Post/ Subject wise & Category wise for each Vacancy Year of all discrepancies/ variations affecting Select/ Extended Panels as reported by the Principals/ Directors/ Controlling Officers and transmit one copy each of consolidated compilation with proper validation/ attestation to the Asstt. Commissioner (Estt.2&3) & Asstt. Commissioner (RPS) immediately for further remedial action (if any) at this end.
- 6) Please write YES/ NO in the cells of columns specified in EXCEL format for displaying eligibility for a specific Vacancy Year.
- 7) The discrepancies in the Name, Post/ Subject and Employee Code, if any, may be mentioned in "Remark/ Discrepancy Column" of EXCEL format attached.
