Sub:- Streamlining NPS issues - Reg.

Madam/Sir,

KVS is having almost 15000 subscribers of NPS at present. Monthly contribution of subscriber is uploaded by Regional office/ZIET/Hqr respectively for their employees on NSDL website. The information of Subscriber which is uploaded on NSDL Website is partially captured from salary Bill(UBI Portal) and partial information of PRAN no., month of uploading, nature of deposit etc. are being filled up by respective office as per information furnished by concerned KV or as available from service records of employee. It has come to notice that above mechanism as adopted is not foolproof, as during cut and paste exercise from different soft files, wrong data is being captured and uploaded.

2.0 In order to streamline above issue, it is proposed that complete information as required to be uploaded on NSDL website against each Subscriber may be directly captured from UBI Salary Portal. For this purpose, certain column as prescribed by NSDL has already been inserted in IT structure of UBI salary Portal and requisite report in the prescribed format is already generating. A program to convert above file into specific language file(java) in terms of specification of NSDL will be inserted shortly, so that prescribed NPS data can be directly captured from UBI Portal and directly uploaded to NSDL website.

- 3.0 Further, to this another problem persist in NPS is uploading of arrears of serving employees and legacy issue. Issue of uploading of legacy contribution had already been taken up with Regional offices and has not yielded fruitful results.
- 3.1 In this regard, Regional office is hereby requested to clear all such issues (arrear+legacy) latest by 30<sup>th</sup> September, 2015 and if required, they may avail services of Data Entry Operators for a period of two/three month in terms of existing KVS Rule position to hire DEO, so that scarcity of manpower may not hamper to resolve this over pending issue.
- 4.0 Regional offices is hereby requested to direct all KVs falling in their jurisdiction to fill up requisite information of NPS Subscriber in salary bill of July, 2015 onwards and RO may confirm accuracy of data of NPS subscriber as uploaded on UBI Portal to the undersigned latest by 10<sup>th</sup> August, 2015, so that correct data of NPS subscriber can be directly captured through UBI Portal and uploaded on NSDL website by respective office i.e RO/ZIET and Hqr on NSDL website.
