


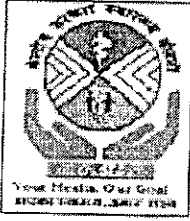

With regard to this Directorate's Office Memorandum dated 13.09.2022 regarding empanelment under continuous empanelment scheme 2022, the undersigned is to convey that in addition to the list of the hospitals (including dental clinics, eye centres and diagnostic laboratories already empanelled, the hospitals as per the list attached (One HCO) have also been empanelled under CGHS in Delhi & NCR with issuance of this order.
