2. The offer of promotion made under SC/ST quota is subject to production of recent certificate obtained from the competent authority of State Govt. in support of his/her continuing to belong to SC/ST as the case may be.

3. Necessary option for fixation of pay should be exercised within a month of joining to the post of TGT.

4. No extension of joining time shall be allowed except for reasons of illness/confinement of the employee duly supported by medical certificate from Chief Medical Officer/Medical Supdtt. / Civil Surgeon of Govt. Hospital/District Hospitals or from Chief Medical Officer of the Hospital of Public Sector undertakings/Projects to which the school is attached/Military or Command Hospital as the case may be. The request, if any, for extension should be submitted through proper channel by 10.05.2016 to KVS (HQ) positively.

5. It is also made clear that representation for either change of place of posting or for extension of time to join the post (other than covered under para-4 above) will not be entertained under any circumstances.

2.(i) The Principal, KV concerned where the teacher is presently working. In case, the employee is willing to join, he/she should convey his/her unconditional willingness/consent to the Kendriya Vidyalaya Sangathan (HQ) through his/her Principal by 16.05.2016. In case, teacher concerned does not submit such willingness/unconditional consent, he/she will be deemed to be not interested in offer of promotion and his/her offer of promotion will stand automatically withdrawn without any further notice. The employee who has accepted the offer of promotion may be relieved positively on or before 26.05.2016 to enable him/her to join the place of posting. Before relieving, it may also be ensured that he/she is not under currency of any penalty and no vigilance/disciplinary case is pending/ contemplated against him/her.

2.(ii) The Principal KV, concerned, where the teacher is presently working, will ensure that the candidate fulfills the required eligibility as per check-list provided by RPS Section, KVS (HQ) (copy enclosed) for promotion to the next higher post. In case, any of the candidate is found ineligible, the Principal concerned will immediately report the matter to Joint Commissioner (Admn.), KVS (HQ) alongwith reasons of being ineligible for taking further necessary action and will not relieve such employee. One copy of the eligibility check-list of eligible candidates will be retained by the relieving Principal and other copy will be enclosed and forwarded to the Principal where the teacher has been asked to report for joining. The Principal will keep the copy of check-list of eligible candidates in the Personal File of the concerned teacher for record. The original online application of the candidate for the post of TGT is being sent separately by post.

3. The Principal, KV concerned where the employee is posted as TGT, with the request to intimate the date of joining of the individual.
4. The Deputy Commissioner, KVS, Regional Office, concerned. He/she is requested to ensure the implementation of the time schedule given in Sl. No.2 (i) above and relieving of the willing employee. The date of relieving/joining of the teacher may also be intimated latest by 10.06.2016 through E-mail.

- b) **For TGT (Hindi):** Hindi as a subject in all the three years.
- c) **For TGT (English):** English as a subject in all the three years.
- d) **For TGT (S.St):** History, Geography, Economics and Pol. Science of which one must be either History or Geography.

IMPORTANT INSTRUCTIONS:

1. The candidate should have studied any two subjects out of the following:

 - (ii) Geography with History/Economics/Political Science.
2. Geography/History should have been studied in all three years of Graduation.

4. Similarly in case of Honours degree in Geography, the candidate should have studied History/Economics/Political Science in first and/or second year of graduation.

e) **For TGT (Maths):** Bachelor Degree in Maths with any two of the following subjects: Physics, Chemistry, Electronics, Computer Science, Statistics.

1. The candidate should have studied Maths in all three years of graduation with any two subjects out of Physics, Chemistry, Electronics, Computer Science, Statistics.
2. In case of Honours Degree in Maths, the candidate should have studied Maths in all the years of graduation and any of two subjects indicated in point No. -1 above at graduation level.
3. BA (Hons.) in Maths and B.Sc. (Hons.) in any subject other than Maths are not eligible for the post of TGT (Maths)

f) **For TGT (Science):** Botany, Zoology and Chemistry.
